Subject: Information to Italian policyholders on the impact of the Brexit.

We refer to the Opinion¹ published on 25 June 2018 by the European Insurance and Occupational Pensions Authority (EIOPA) on disclosure of information by insurance undertakings to policyholders about the possible impact of the withdrawal of the United Kingdom from the European Union.

In particular, EIOPA considers it necessary that insurance undertakings:

- I. duly inform policyholders and beneficiaries of existing contracts on the possible impacts of the Brexit contingency plans on their contractual position;
- II. duly inform potential policyholders in order to enable them to make an informed decision before concluding or renewing the contract;
- III. inform their respective distribution networks to enable them to provide correct information to their current and potential customers.

On account of the above and of the need to ensure the widest possible dissemination of information for Italian policyholders, we remind insurance undertakings operating in Italy from the United Kingdom under the right of establishment and/or the freedom to provide services, where they have not already done so, to take the following action without delay:

- a. send adequate information on an individual basis about the impact of Brexit to their Italian policyholders and beneficiaries, according to the guidelines contained in the EIOPA Opinion;
 - b. publish similar information on their internet site;
 - c. give appropriate instructions to their distribution networks about the information to provide to their current and potential customers.

We kindly ask you to send us confirmation, by 30 November 2018, of the delivery of this information, describing the initiatives adopted.
